National Federation of Nonpublic School State Accrediting Associations (NFSSAA)

The annual meeting for NFSSAA was held on June 14-15, 2023, in Detroit, MI. The meeting focused on state membership reports, and a discussion regarding the landscape of accreditation in each state focusing on association priorities, political factors, economic climate, technology factors, customer needs, uncertainties, and other trends. Council for Private Education (CAPE)

The annual State CAPE Network (SCN) meeting was held on July 19-11, 2023, in Asheville, NC. The meeting focused on coalition building, legal hot topics, amicus briefs, educational landscape, early learning, private school participation in NAEP, and the accreditation landscape. Arkansas nonpublic schools were represented in the meeting by Kristine Grelle, AR SCN representative.

Important Updates

NEW ANSAA 2023-2024 Policy Manual

The ANSAA Board of Directors approved a reorganization of the ANSAA Policy Manual. The previous manual included twelve standard areas whereas the new document contains seven. Although some standards have been combined and rewritten for clarification, there are no changes in the mandatory requirements.

NEW ANSAA Self-Study

The 2023 Edition of the ANSAA Self-Study has revised to reflect the new reorganization of the standards found in the ANSAA Policy Manual, Edition 2023. Federal Funds

EANS I (CRSSA) - As of June 2023, over \$12M of the \$18M designated for ANSAA participating member schools has been used. The deadline to use these funds is September 30, 2023.

EANS II (ARP) – As of June 2023, about \$700,00 of the \$2.6M allocation has been used by the eleven schools that qualified for these funds which expire in September 2024.

A NEW grant using funds reverted from EANS to GEER has been made available for schools that did not qualify originally for EANS 2 because they took a PPP loan or didn’t meet the poverty level stipulated in the grant. Arkansas Activities Association / AAA

The AAA Governing Body Meeting was held on July 24, 2023. The focus of the meeting was to consider the following six proposals to amend the AAA Constitution and Bylaws which were voted on by the state membership.

Proposal No. 1 / Jr. High Travel	* Passed
To allow junior high schools more flexibility in scheduling games to fulfill a season.	
Proposal No. 2 / Coaches Education – Employment	* Passed
To give licensed teachers more flexibility.	
Proposal No. 3 / Financial Aid – Service Providers	* Passed
To evaluate the existing financial aid third party service providers – expand options for nonpublic schools to coordinate financial aid assistance.	
Proposal No. 4 / Electronic Distribution	* Passed
To promote more effective, timely communication concerning official AAA business.	
Proposal No. 5 / Non-Athletic Activities – National Contests/Events	* Passed
To provide clarity on activities groups attending national level contests and events due to the discontinuation of the NASSP list.	
Proposal No. 6 / 4A Baseball, Basketball, Softball Conferences	* Passed
To provide more opportunities to reduce travel, increase regional/state participation.	
Proposal No. 7 / NEW Competitive Equity – Football	* Passed
To allow for an even number in each football conference in addition to reevaluation classification limits by enrollment.	
Proposal No. 8 / Competitive Equity – 2 Year Lookback	* Passed
To effectively administer the Competitive Equity Factor Plan on a consistent two-year basis for nonpublic schools instead of a four-year basis.	

Arkansas Legislation

The Regular Session of the 94th General Assembly was a busy one. At the forefront of many of the minds of nonpublic schools is the impact of [Act 237](#) known as the LEARNS Act. Included in the law is the opportunity to participate in Education Freedom Accounts which provides funding up to 90% of the State’s prior year per-student foundation funding amount, up to around \$6,600 for the 2023-2024 school year. Below are additional bills that have been passed by legislators this session that will impact nonpublic schools in Arkansas. The full text of the bills waiting on Governor Sanders’ signature and the Act that has already been signed are linked to each for your convenience.

- [Act 286](#) – Requires private (and public) schools to have at least two employees trained for implementation of a student seizure action plan by the 2024-2025 school year.
- [Act 669](#) – Allows qualifying students to receive funds from both the Arkansas Children’s Educational Freedom Account and the Philanthropic Investment in Arkansas Kids programs.
- [Act 732](#) – Amends laws related to teacher licensure, including qualifications for obtaining a license and the length of time that a provisional teaching license is valid.
- [Act 737](#) – Requires automated external defibrillators (AEDs) at school-sponsored sporting events for grades 7-12.
- [Act 748](#) – Defines athletic participation for homeless students and allows soccer players to play both club and high school soccer at the same time.
- [Act 764](#) – Requires storm shelters for new construction at all educational facilities (includes private schools).
- [Act 787](#) – Requires all private (and public) schools to keep exterior doors closed and locked at all times other than transitions and provide a way for occupants to leave the building in case of a fire.
- [Act 792](#) – Arkansas Activities Association (AAA) registered volunteers of any educational entity must complete statewide and nationwide criminal records checks.
- [HR1081](#) – Strongly encourages private schools to participate in professional development courses on bullying in schools and recognizing and addressing child maltreatment issues.

- ANSAA Financial Review Form - Audit letters are no longer required to be filed annually; however, every school must complete the ANSAA Financial Review Form.

ANSAA Accreditation Renewal

The following schools must apply for ANSAA Renewal during the 2023-2024 school year (due the fourth year of the seven-year cycle): Academy of Excellence, Eureka Springs; Christ the King School, Little Rock; Episcopal Collegiate School, Little Rock; Immaculate Conception School, Fort Smith; Our Lady of the Holy Souls School, Little Rock; St. Joseph School, Conway; St. Joseph Catholic School, Paris; and West Side Christian School, El Dorado.

Schools must include with the renewal form a \$100 filing fee and a copy of the school's current Strategic Plan.
